Course description:

Looking at recent events through a queer, feminist and diasporic lens, this module is engaged with questions of community building, solidarity and the inescapability of ambivalences and contradictions in politics that work towards radical social transformation.

This course is focused on theory (making sense of the world) and epistemology (making sense of making sense of the world). We will discuss how theory and epistemology are intertwined with activism, research practice and everyday life. The module aims to enable students to reflect critically on knowledge production and to 'translate' theoretical concepts across disciplines, languages and contexts.

Teaching/Learning Methods: The course consists of lectures, tutorials and class discussions. We will be using Moodle to access course documents, such as the updated syllabus, weekly lecture notes and sample reaction papers. We will also use BLE for occasional online discussions on specific topics as well as to exchange relevant information, resources and links.

Assignments:

I. Reaction Papers (50%).:

Students are asked to write brief reaction papers (1000 words) based on the assigned readings. Students are allowed to submit 3 reaction papers. The grade is based on the 2 best.

II. Essay (50%):

The 2000 word essay is due on Jan 8th, 2019. We will discuss essay topics after reading week.
